## Individual Take-aways

Looking for pain points that can help with. – ANONYMOUS

Can help others if use a unified/standardized framework.

## Presenter Take-aways

Need an inventory or audit of the existing resources. Where are people spending money outside of the agency (pain points). How can they serve people's needs. – ANONYMOUS

I would consider reaching out to whomever oversees the IDEA allocations. If you can coordinate with the on norming the definition of coordinated early intervention systems to align with the framework in your project, then you can use that as a point of common support for districts. For example, a district identified for disproportionality and in need of improvement via ESSA then it's a compelling argument to unify the approach to supporting the districts and the evidence behind MTSS stands on it's own.

Summary of Kristen's question for Annette: grab what you can from those grants that are closing in September and fold what is reasonable and logical into your SPDG. Use your SPDG as the sustainability avenue for your agency's grants that are closing. Hang onto those grant components that are important but don't have a reasonable and logical fit with your SPDG as they will be able to start forward motion when your agency receives other grants. Marrying these critical grant components should not require additional funds. Remember to link these sustainability steps in your annual report.
