Kristen Brown/CO Director Office of Learning Supports:

Our Districts have to complete a family engagement survey every year.

Selina Merrell:

We do a survey as well.

Theresa Farmer:

WeFamily survey information and information gathered at our annual Family Focus meetings for parents of Transition aged students.

Theresa Farmer:

Premature send: We use yearly Family Survey information. We use information gathered from family members who attend the annual Family Focus meetings for parents of Transition age students.

Maren Henderson (she/her):

Reflection questions (aloud or in chat): What do YOU believe about students and families in the districts you support? How do you act upon your beliefs? Do any of the beliefs we shared stand out to you?

Jennifer Coffey:

What do you believe about students and families in the districts you support?

Lucinda Kelley:

They love each other very much but they are sometimes overwhelmed with life stressors which impact achievement and access to resources.

Hollie Filce:

We believe that families must be a part of all decisions and planning.

We find that sometimes schools ask employees of the district to also participate as "parents" on the team.

SPDG 3.0 K-12 Initiatives:

#1 is critical to getting past participation to engagement, whether it is about family events or IEP meetings or homework support.

GA Karen Suddeth:

FPE is an important component of infrastructure. If infrastructure is not solidly in place, it could be a barrier to success.

Theresa Farmer:

We believe families should be a critical part of school and community decisions. We ask district partners to include parent representation when we schedule MOU meetings. We have a long way to go.

Peg S:

There is a huge difference between participation or involvement and family engagement. All students can learn just need the right supports. Always presume positive intent.

Lucinda Kelley:

I love the definition of cultural humility! I think it is very related to equity as well - but it is how we as individuals see ourselves in the bigger picture of humanity. So many times I see educators who see themselves as better, smarter, more capable - it is difficult to build relationships when that is the prevailing attitude.

Powerful!

Highlights the need to focus on the social emotional development of the adults.

GA Karen Suddeth:

I would ask Allison to teach me so that I could ensure my school is more aware and inclusive.

Hollie Filce:

When she said her son has to advocate for himself when he's so young and shouldn't have to do that at his age....so true.

Bernadette.Gomez:

I as a bilingual/bicultural person learned about the daily "traveling" of cultural identity adaptation, when no support was ever provided by public schools. In the end, it is a gift that grows the synapses of the brain, and actually increase and strengthen IQ!

Bernadette.Gomez:

Role modeling, fostering and using multicultural curriculum!

Bernadette.Gomez:

Just a friendly suggestion to maybe consider changing the label of American Indian, to Native American and American Indian that would represent Eastern Indian heritage?

Peg S:

I think Florida would have many similar findings.

1. no; yes 2. the first thing I would do would be to work on relationships--repairing, making, giving value to all voices framing this work both internally with staff and externally with community and the families served
